- Basis of Design calculations and documents, as prepared by a Florida Registered Professional Engineer.
- A Brief synopsis of plant construction/modification.
- Appropriate fee. Submit a check payable to the Broward County Board of County Commissioners.

WWTP Construction License Fees

(Per Broward County Administrative Code, Chapter 40.23, effective 05/01/25)

For Section 27-201(a)(5), Wastewater Treatment Plants Fee

- (a) Proposed Wastewater Treatment Plants Construction Phase License Fee:
- (1) Per gallon of design capacity.....\$0.075
 - (2) Minimum fee shall not be less than\$750.00
 - (3) Maximum fee no more than.....\$12,300.00
- (b) Proposed Modifications License Fee:
- (1) Proposed modification or revision that does not change design capacity\$1,350.00
 - (2) Modification to Advanced Wastewater Treatment or Spray Irrigation
 - a) Per gallon of design capacity (17 mills)\$0.0255
 - b) This fee shall not be less than\$247.00
 - c) Nor more than \$4,920.00
